# Representative Matters

#### **Personal Injury**

- Obtained a zero liability verdict at arbitration in a wrongful death lawsuit in which the plaintiff sought damages in excess of \$1 million.
- Successfully represented a Fortune 500 corporation in an automobile accident where the plaintiff alleged traumatic brain injury, disk herniations, and nerve damage.
